ORDER SETTING EXECUTION DATES
PURSUANT TO 22 O.S.2021, § 1001.1
(PHASES TWO, THREE, FOUR AND FIVE)

This matter comes before the Court on the State of Oklahoma's request for execution dates in the above-styled and numbered cases, pursuant to 22 O.S.2021, § 1001.1(D),(E). These nineteen inmates have exhausted all state and federal appeals of their convictions and death sentences. The setting of execution dates for these inmates was stayed indefinitely by this Court pending the investigation of, and adjustments to, Oklahoma's lethal injection protocol and resolution of federal litigation challenging same.

The State advises that judgment was recently granted in full, after a trial on the merits, against these inmates' challenges in federal court to the constitutionality of Oklahoma's lethal injection protocol. *See Glossip v. Chandler*, 2022 WL 1997194 (W.D. Okla. June 6, 2022). In light of this federal court ruling, the State tells us there are no further legal impediments to carrying out the executions of these inmates. With one exception, the State requests these inmates be

scheduled for execution based on the order in which they exhausted the appeals of their convictions and death sentences.¹

We have already set execution dates for six death row inmates—Coddington, Glossip, Cole, Fairchild, Hanson and Eizember—who also were plaintiffs in *Glossip v. Chandler*. The six execution dates for these inmates commence on August 25, 2022, and end January 12, 2023.

The State says it has consulted with the Oklahoma Department of Corrections (ODOC) regarding an appropriate date for carrying out the execution of each of the inmates in the present cases. The State has not, however, submitted a proposed execution schedule. Instead, the State has tendered a list of conditions governing the setting of execution dates. In order for ODOC to meet its own operating procedures, and to accommodate the scheduling of clemency hearings before the Pardon and Parole Board, the State requests *inter alia* that each execution be carried out on a Thursday and that executions be scheduled no less than four weeks apart.

¹ The State requests that Wade Lay's execution be scheduled for a date after proceedings are held in Pittsburg County District Court in May 2023 to determine his competency to be executed.

Based upon a thorough review of the record before this Court, we find that the setting of execution dates in these cases is now appropriate and required pursuant to 22 O.S.2021, § 1001.1(D),(E). The stays previously entered by this Court in these cases are lifted. The sheer volume of cases, however, along with the execution dates already ordered and the need to ensure compliance with constitutional requirements make it necessary to establish an execution timetable that offers flexibility in scheduling and allows for this Court to respond to unforeseen contingencies. Therefore, we hereby order the execution of the judgments and sentences of death in these cases to be carried out as follows:

1. The execution schedule is divided into phases consisting of six inmates each being set for execution at least four weeks apart. An open month will separate each phase of the execution schedule to accommodate rescheduling if needed. Coddington, Glossip, Cole, Fairchild, Hanson and Eizember were, by separate order, already assigned to Phase One of the execution schedule which commences on August 25, 2022, and ends on January 12, 2023.

2. The Phase Two execution dates are therefore set as follows:

5. The Phase Five execution date is set as follows:

These execution dates are (obviously) subject to change due to unforeseen delays or other circumstances that may arise with inmates in other phases of the execution schedule. This Court will adjust the execution schedule as needed to ensure that executions progress in a timely and orderly manner. Towards that end, this Court will confirm by written order, at an appropriate date before the commencement of each phase, the execution dates for the inmates in Phases Two, Three, Four and Five.
